# **HUMAN RELATIONS COMMISSION**

Regular Meeting Minutes City Hall Room 1050 March 22, 2023

#### 1. CALL TO ORDER

1<sup>st</sup> Vice President Courtney Morgan-Greene called the meeting to order at 12:10 p.m. along with, 2<sup>nd</sup> Vice President Melany De La Cruz-Viesca, and Commissioners Nirinjin Singh Khalsa, Herpsima Khatchadorian, Maria Roman-Taylorson and Stacy Twilley in attendance.

Commissioner Rosa Russell arrived at 12:11 p.m.

Commission President Angelica Solis-Montero, Commissioner Irene Tovar and Commissioner Brooke Wirtschafter were absent.

Those also in attendance included Capri Maddox, General Manager; Claudia Luna, Assistant General Manager; Barak Vaughn, Deputy City Attorney; Francisco Ortega, Senior Project Coordinator; Liliana Villa, Human Relations Advocate, and James K. Williams, Commission Executive Assistant II.

A quorum was established and the meeting proceeded.

#### 2. PUBLIC COMMENT

The public comment period was opened. James Steinberg, the son of former Human Relations Commission President, Dr. Warren Steinberg (1978-1983) addressed the Commission. He spoke about his Father's legacy and offered to donate the bulk of Dr. Steinberg's research, on the Human Relations Commission, to the City Archive. Following this speaker the public comment was closed.

#### 3. APPROVAL OF THE MINUTES

The Commission discussed the minutes of the February 22, 2023 Regular Meeting.

#### 7. AD HOC COMMITTEE UPDATES

- a. Commissioner Courtney Morgan-Greene spoke about the progress of the Young Adult Dinner Dialogues which completed two sessions. The first in San Pedro and the second at USC. Scheduled for five events (1 per month), the dialogues allow five officers to meet with ten community members. Entrance and exit surveys were collected at these successful events.
- b. Commissioner Stacy Twilley gave an update on the LA Together Podcasts. Three podcasts were completed and are available and being broadcast on Apple and Spotify.
